_____ (a) I AGREE that prior to participating in an event I will inspect the course, facilities, equipment, and areas to be used and

if I believe any are unsafe, I will immediately advise the person supervising the event activity facilities or area;

_____ (b) I waive, release and discharge from any and all claims, losses or liabilities for death, personal injury, partial or permanent disability, property damage, medical or hospital bills, theft or damage of any kind, including economic losses, which may in the future arise out of or be related to my participation in or my traveling to and from a

Tri Fusion event the following persons or entities: TRI FUSION, TRI FUSION MEMBERS AND BOARD OF DIRECTORS, SPONSORS, RACE DIRECTORS, EVENT PRODUCERS, AND VOLUNTEERS EVEN IF SUCH CLAIMS, LOSSES, OR LIABILITIES ARE CAUSED BY THE NEGLIGENT ACTS OR OMISSIONS OF THE PERSONS I AM HEREBY RELEASING OR ARE CAUSED BY THE NEGLIGENT ACTS OR OMISSIONS OF ANY OTHER PERSON OR ENTITY;

_____ (c) I ACKNOWLEDGE that there may be traffic or persons on the course/route and I ASSUME THE RISK OF RUNNING, BIKING, SWIMMING OR PARTICIPATING IN ANY OTHER TRI FUSION EVENT OR EVENT ATTENDED BY MEMBERS OF TRI FUSION. I also ASSUME ANY AND ALL OTHER RISKS associated with participating in Tri Fusion sanctioned events including, but not limited to, falls, contact and/or effects with other participants, effects of weather including heat and/ or humidity, defective equipment, road conditions, water hazards, contact with other swimmers or boats and any other hazard that may be posed by spectators or volunteers. All such risks being known and appreciated by me, I further acknowledge that these risks include risks that may be the result of negligence of the persons or entities mentioned in the above paragraph or of other persons or entities;

or liabilities that I have waived, released or discharged herein;

claims made or liabilities assessed against them as the result of : (i) my actions or inaction, (ii) the actions, inactions or negligence of others, including those parties hereby indemnified, (iii) the conditions of the facilities, equipment or areas where the event is being conduction, and (iv) any other harm caused by occurrence related to a Tri Fusion event

Severability: Should any portion of this agreement be deemed invalid or unenforceable, the remaining portions shall remain in effect and shall remain a valid agreement between the parties.
